- 5. The construction of works must be completed within the estimated cost in all respects without involving cost and time overrun and
- 6. There should not be any change of proposed works. Diversion of fund from one work to another will also not be entertained under any circumstances.
- 7. As directed by Finance (EC-III) Deptt. SPV may be created with professional manpower to execute the above Project.
