I am directed to convey the Administrative Approval and Financial Sanction of the Governor of Assam for an amount of **Rs.189.50 Lakh (Rupees One Crore Eighty Nine Lakhs Fifty Thousand) only** for the following schemes to be executed by the Executive Engineer, Guwahati Mechanical Division W.R. Department, Guwahati-29 during 2017-18 :-

3	Dewatering of storm water of Guwahati City with 4 nos. of pumps at Pandu and Sadilapur pumping station	9.50
4	Dewatering of logged water/storm water from low lying areas of Guwahati City with 10 nos. of Trolley mounted and 3 nos. 10/12 HP pumps	50.00
5	Maintenance and periodical cleaning of Sarusola Beel drainage channel including Sarusola Beel for free flow of storm water of Guwahati City	45.00
6	Repairing and maintenance of all sluice gates on both bank of river Bharalu/Mora-Bharalu etc.	25.00

The issuance of Administrative Approval & Financial Sanction is subject to the observance of the following terms & conditions:-

1. Observance of all codal financial rules & procedures including the provision of AFRBM Act, 2005,
2. The Work is required to be executed as per Plan & Estimate during 2017-18. No alternation of items is permissible at any cost. No escalation will be allowed and no additional works should be taken up,
3. Deduction of GST and other taxes require to be made at sources and deposited into Treasury through challan,
4. Compliance of CVC rules guidelines and rates for different items requires to be fixed calling NIT through E-Tendering,
5. The construction of works must be completed within the estimated cost in all respects without involving cost and time overrun and
6. There should not be any change of proposed works. Diversion of fund from one work to another will also not be entertained under any circumstances.
7. The Executive Engineer, Guwahati Mechanical Division W.R. Department, will limit the expenditure to the extent of **Rs. 189.50 Lakh** only within the admissible time limit.

The expenditure is debitable to the head of Account "**4217 Capital Outlay on Urban Development-01-State Capital Development-051-Construction-2173-City Infrastructure-000-No sub sub Head-13-Major Works-99-Others (SOPD-G)**" under Grant No. 73 for the year 2017-2018.
