Sub : Administrative Approval for "23 Nos. of Schemes for improvement of Roads & bye-lanes" under P.W. (Roads) Department during 2017-18.

Sir,

I am directed to convey that the Governor of Assam is pleased to accord Administrative Approval for an amount of **Rs. 1999.28 Lakh** (Rupees Nineteen Crore Ninety Nine Lakhs Twenty Eight Thousand) only for the **"23 Nos. of Schemes for improvement of Roads & bye-lanes" under P.W. (Roads) Department** during 2017-18, as per Annexure-A to be executed by the Executive Engineer, P.W. (Roads) Department, Guwahati City Division- I, Guwahati Road Division & North Guwahati State Road Division (NGSRD) subject to the observance of the following terms and conditions:-

1. Observance of all codal financial rules & procedures including the provision of AFRBM Act, 2005,
2. The Work is required to be executed as per Plan & Estimate during 2017-18. No alternation of items is permissible at any cost. No escalation will be allowed and no additional works should be taken up,
3. Deduction of GST and other taxes require to be made at sources and deposited into Treasury through challan,
4. Compliance of CVC guidelines and rates for different items requires to be fixed by calling NIT through E-Tendering for the schemes above Rs.20.00 Lakh,
5. The construction of works must be completed within the estimated cost in all respects without involving cost and time overrun and
6. There should not be any change of proposed works. Diversion of fund from one work to another will also not be entertained under any circumstances.
7. The Executive Engineer, PWRD, (Guwahati City Division- I, Guwahati Road Division & North Guwahati State Road Division (NGSRD) will limit the expenditure to the extent of **Rs. 1999.28 Lakh** only within the admissible time limit.

The expenditure is debitable to the head of Account **"4217 Capital Outlay on Urban Development-01-State Capital Development-051-Construction-2173-City Infrastructure-000-No sub sub Head-13-Major Works-99-Others (SOPD-G)"** under Grant No. 73 for the year 2017-18.

This has been issued as per with the approval of Finance (EC-III.) Department's concurrence vide U/O No.1492 /2017 dated 14.12.2017 and as per DFP Rule 1999, as amended.
