Sub : Revised Administrative Approval and Financial Sanction for "Improvement of Road from Saturbhuj Namghar to Manisha Apartment, Beltola".

Sir,

I am directed to convey the Revised Administrative Approval for an amount of **Rs.24.92 Lakh (Rupees Twenty Four Lakhs Ninety Two Thousand) only** and Financial Sanction for an amount of **Rs.2.82 Lakh (Rupees Two Lakhs Eighty Two Thousand) only** of the Governor of Assam for the Scheme "Improvement of Road from Saturbhuj Namghar to Manisha Apartment, Beltola" during 2017-18, to the Chief Executive Officer, Guwahati Metropolitan Development Authority (GMDA), subject to the observance of the following terms & conditions:-

1. Observance of all codal financial rules & procedures including the provision of AFRBM Act, 2005,
2. The Work is required to be executed as per Plan & Estimate during 2017-18. No alternation of items is permissible at any cost. No escalation will be allowed and no additional works should be taken up,
3. Deduction of GST and other taxes requires to be made at sources and deposited into Treasury through challan,
4. The construction of works must be completed within the estimated cost in all respects without involving cost and time overrun and
5. There should not be any change of proposed works. Diversion of fund from one work to another will also not be entertained under any circumstances.
6. The Chief Executive Officer, GMDA will limit the expenditure to the extent of Rs. **Rs.22.10 Lakh** only within the admissible time limit.

The expenditure is debitable to the head of Account "4217-Capital Outlay on Urban Developemnt-01-State Capital Development-051-Construction-5936-Improvement of Infrastructure of Guwahati City-000-No Sub Sub Head-35- Grants for creation of Capital Assets-99-Others" (SOPD-ODS) under Grant No. 73 for the year 2017-2018.

This has been issued as per DFP Rules 1999, as amended.

Earlier Administrative Approval No. GDD.200/2015/28 dated 16.02.2016 stands cancelled.
